CIRCULAR

Subject: Suspension of all International passengers flights to/from Bangladesh.

- 1. Following the government guidance and instruction, with effect from 0001 BST on 14 April 2021 until 2359BST on 20 April 2021, all international passenger flights to/from Bangladesh shall remain suspended.
- 2. Medevac, Humanitarian/Relief, Cargo, Technical Landing (for refueling only) and the flights cleared under special consideration shall remain out of the purview of this suspension. Standard disinfection, sanitization and social distancing procedure, published by CAAB or other competent authority of the government, for the passenger, crew, equipment and aircraft (inflight or on ground) shall strictly to be maintained/ followed for such flights.
- 3. Irrespective of the COVID-19 vaccination and unless otherwise relaxed by the competent authority, all passengers coming/leaving Bangladesh by the flights mentioned in Paragraph-2 above, shall mandatorily possess PCR based COVID-19 negative certificate. The PCR test shall be done within 72 hours of the flight departure time. Passengers coming by the flights cleared under special consideration shall strictly have to complete a 14 (fourteen) days institutional quarantine at government nominated facilities or at hotels on passenger's own expenses.
- 4. The circular published on the carriage of passengers (260 in Wide Body and 140 in the Narrow Body aircraft) vide CIVIL AVIATION CIRCULAR (CAC-GEN) 06/2020 issued on 27 September 2020 shall also apply to the flights stated in paragraph-2.
- 5. This circular supersedes all previous circulars published time to time on the same issue.
